- Submission through the online portal
- Abstract length: Maximum 250 words with 5 keywords
- Full-length research papers: 6,000–8,000 words
- Formatting style: APA 7th Edition referencing guidelines
- Submissions must be in MS Word (.docx) format only
- Times New Roman, 12 pt, 1.5 line spacing
- Manuscript should include author information (name, affiliation, and email address)
- Maximum Turnitin similarity threshold: 19%
- AI-assisted writing must be explicitly declared

Top 20–30% of full-length papers will be considered for publication in Scopus/WOS-indexed conference proceedings Book (with ISBN), published by Taylor & Francis, subject to peer review.
